**ORDER**

Petitioner has filed this petition under Article 226 of the Constitution of

India making a prayer that respondent No.4 be directed to consider and decide representation of petitioner.

2. Counsel appearing for the petitioner submitted that petitioner's father Dhirendra Kumar Pandey died on 20.12.2016, who was having Savings Pension Account No.109010006684 in Dena Bank. It is submitted that account in credit of his father be given to petitioner. It is submitted that bank is not considering his application and orally informing him that excess money has been credited into account of his father therefore, no money can be paid to him.

3. Heard the counsel for the parties.

4. Petitioner has a right that his application be adjudicated by the bank in accordance with law.

5. Considering the same, writ petition filed by petitioner is disposed off directing Branch Manager, Dena Bank, Anand Nagar, Adhartal Jabalpur to consider representation of petitioner and inform him reasons in writing why amount standing in credit of his father cannot be given to petitioner despite fact that petitioner is nominee in said saving account. Fresh representation, which will be filed by petitioner within 15 days before said authority, be considered and decided within a period of 45 days from the date of receipt of certified copy of the order passed today.

6. No opinion is expressed on the merits of the case.

7. With aforesaid direction, writ petition is **disposed off**.
